GYRFALCON (GB) rated a clear lead inside, was challenged approaching the quarter pole, dueled clear of the runner-up into the lane and held well with a steady drive. SHORT HAIR rated close off the rail, edged toward contention nearing the quarter pole, drifted outward through the upper stretch then finished evenly to be second best. EVENING CLINIC, unhurried inside, angled out through the final turn, entered the stretch six wide and bid mildly to show. ESTABLISH broke a step slow, settled in off the rail, started his drive angling outward on the final turn and finished evenly widest. FAMILY APPEAL saved ground off the pace after an awkward start, bid into the final turn, was five wide entering the lane and finished evenly. LONGFORD ARMS rated off the pace inside, gave chase into the final turn then showed no response from the eighth pole. MAMBO MOON was kept off the pace and off the rail then came evenly through the stretch. SOCIETY SAM never factored.
