TIME FOR A WINNER set a pressured fast pace two deep, moved to the rail approaching the turn, was driven into the lane and held on well. RED ELEPHANT chased the pace from the outside, entered the stretch five wide, found his best stride through the lane and was gaining late. RED PETE chased the pace off the rail, dueled for place midstretch but was caught nearing the wire. CHAC MOOL drew briefly clear on the chute, chased the pace three and four wide then leveled off through the lane. AL N CON pressured a fast pace inside, lost momentum into the turn then weakened through the lane. SMOKE IT OVER raced well back saving ground.
