PHOENIX COURT settled inside, angled out in midstretch and made up some ground. MY APPEAL didn't break sharply then was hustled to the front soon after, was clear midway on the backstretch, stayed out from the rail and weakened. DIOSA DEL SOL was unhurried while racing well out from the rail and made up some ground late. GITANILLA ducked out leaving the gate then fell back soon after and was outrun inside. MELANCOLIA showed speed two wide for about a half then stopped.
