**Footnotes**

CALL TIGER was in hand early, began a rally four wide into the far turn, reached the front before six furlongs, drew out in early stretch and held. MENIFEE SIX lagged inside, rallied three wide around the final turn and finished fast outside. ECHSTEIN VILLAGE was slow early, was put to a drive while moving closer three wide on the final turn then had nothing left for the drive. BROTHER IN ARMS was sent clear, stayed out from the rail while making the pace for about six furlongs then drifted badly through late stretch. BIRD'S I D was caught wide around the first turn, edged closer two wide between horses on the final turn then flattened out. FULL RECOVERY advanced inside on the backstretch then tired. CHIEF SPEED raced three wide around the first turn then stopped. PENNSYLVANIAEXPRESS stayed out from the rail and stopped.
