AWESOME SINGER dueled or the lead on the inside, began to shake clear into the stretch, carried the lead through the finish and won driving. SKYLINE DRIVE ran towards the rear while on the rail, rounded the turn for home in the three path but had to swing wide into the six path at the top of the stretch, uncoiled an outside rally but got brushed with a furlong to go by AMANDA'S BEST when INSUFE drifted out. INFUSE sat well rated off the pace while sitting between horses, went three wide into the stretch with a rally but drifted out at the eighth pole bumping into AMANDA'S BEST in the process, shook it off and was all out through the finish. AMANDA'S BEST went around both turns in the two path while sitting well rated off the pace, began to move closer to the lead turning for home and entered the stretch in the four path ran gamely through the stretch but got squeezed and jostled around at the eighth pole when INFUSE drifted out. SWEET MAGGIE MAE ran towards the rear clinging to the rail, swung into the stretch in the five path and began to rally but her hole closed in at the eighth pole, she angled out then continued the rally from there. MY MO tracked the pace while going two and three wide around the turns, was full of run at the quarter pole then ran gamely through the stretch towards the inside. I'M NOT JOKING vied for the lead on the outside going two wide around the first turn until she flattened out with three eighths to go. DIRTY DOZEN was allowed to settle off the pace while going two wide around the turns but had no response. FLOATING BY went two and three wide around the turns while sitting towards the rail and finished evenly. MISS HELEN sat well rated off the pace while on the inside, stopped at the quarter pole and was eased down the lane. THERE WERE TWO OBJECTIONS AND BOTH WERE DISALLOWED. THE FIRST WAS THE RIDER OF DIRTY DOZEN CLAIMING AGAINST THE RIDER OF AWESOME SINGER AT THE START. THE SECOND WAS THE RIDER OF INFUSE CLAIMING AGAINST THE RIDER OF SKYLINE DRIVE FOR INTERFERENCE AT THE EIGHTH POLE.
