BALLERINA KITTEN stalked the pace between horses while going three wide around the turn, swung into the stretch in the four path while taking the lead and edging clear, lugged in through the final furlong while rider stayed with right handed urging through the finish. TEN SILVER DOLLARS got bumped by TINTINNABULATION at the break but quickly shook it off, went up and chased the pace on the inside then ran all out through the finish. WILD NOTORIOUS lugged in at the break and bumped into TINTINNABULATION in the process, shook it off and went up to stalk the pace between horses, went two wide around the turn and took the lead briefly at the quarter pole but failed to sustain that run. TINTINNABULATION got pinched back at the start then was allowed to settle off the pace while on the inside, swung into the stretch in the four path but lacked the needed rally. GANS' PIPEDREAM stalked the pace on the outside while going for wide around the turn, weakened for the drive. BLEU MOON TYPHOON sat well rated off the pace while running between horses, went two wide around the turn but swung into the stretch in the six path where she lacked a rally. NATE'S LADY E hit the gate at the start then sat well rated off the pace, took the turn three wide but swung into the stretch in the seven path then had no response when asked for more. BOARDWALK RUN was void of early and late speed, cruised in the two path and was able to pass a tired rival. TALITHA KOUM had a clear early lead while on the inside

but came up empty at the three eighths pole. SULTRY START was reluctant to load then flipped when the gates opened, walked off. THERE WAS A STEWARDS INQUIRY INTO THE START OF THE RACE REGARDING SULTRY START, NO ACTION WAS TAKEN. THERE WAS A CLAIM OF FOUL BY THE RIDER OF TINTINNABULATION AGAINST WILD NOTORIOUS FOR ALLEGED INTERFERENCE ALSO AT THE START, AND AGAIN NO ACTION WAS TAKEN.
