FEDERAL CASE was well placed on the inside and made a inside bid in the stretch and drew clear by the sixteenth pole to prove best under mild drive. EQUAL JUSTICE set a pressured pace two wide and dug in gamely in the stretch, could not go with the winner late but held place award. HIS NAME IS SUE pressed the pace and made a three wide bid leaving the turn but hung in the drive. MANAHAWKIN was reserved early three wide, then dropped down to the inside on the turn and had a belated rally. VENOMOUS STATE was rated along the inside early, came three wide into the drive but had no kick. HOT N SPICY LOVE was reserved early on the inside and lacked a rally. SEPTIMIUS SEVERUS was allowed to settle early, came five wide into the drive and had no rally.
