Footnotes

JESSICA rated the pace inside, came under pressure leaving the three eighths pole, was caught past the five sixteenths, gave chase from that point and was eased around KALENJIN into the lane, dug in for the lead past the sixteenth pole and ran clear toward the wire. The latter settled off the pace in the three path the first turn, bid at the three eighths pole and took the lead three wide past the five sixteenths, angled in across the path of Dinner At Five into the far turn, ran at the rail through the turn and dug in under steady handling, but was caught flattening stride later yards. ALPINE MOON saved early ground then angled out with a bid toward the five sixteenths pole, ran in the five path of the far turn and finished evenly. LADY MACHO saved ground off the pace, bid at the rail into the far turn, angled to the five path through the turn, came back inward past the eighth pole and finished evenly. DAZZLE ME settled off the early pace in the three and four paths then rounded the far turn about the six path. DINNER AT FIVE stalked off the rail then challenged at the three eighths pole, dueled between horses from that point, was pinched back nearing the quarter pole, continued chase into the far turn but weakened past the eighth pole. FLOATING BY saved ground. SKI BUNNY settled off the pace in the two and three paths, picked up the chase nearing the three eighths pole but weakened into the far turn. The Stewards reviewed a claim of foul against the rider of Roof Top Bar, lodged by the rider of Dinner At Five, and disqualified the former to sixth place for coming in on the latter nearing the quarter pole.
