MIDNIGHT ACT was rated four to three wide, made a three wide bid off the turn but needed more late, held show award. REDEEM EDDIE was reserved early three wide, made a four wide bid leaving the quarter pole but flattened out. WISH FOR PEACE was reserved early on the inside, eased out on the turn and came five wide off the turn and had no significant rally. STRAWBERRY TREAT chased the pace on the inside and weakened.
