ALVY raced off the pace into the far turn, teed up four deep leaving the quarter pole, relentless pursuit four then three wide through the final sixteenth, nailed the victory with one final push. PIT STOP MAN vied outside around the first turn, dueled two path around the far turn, dug in outside rival leaving the sixteenth marker, nipped at the wire. ZEN MASTER vied inside around the first turn, then dueled inside leaving the quarter pole, chased on gamely along the rail to the wire, settled show. AL LOVES JOSIE vied between around the first turn, once strait rated back off the top pair for the run into the far turn, bid three deep leaving the quarter pole, evened out through the wire. SUBJECT TO CHANGE tracked the pace along the rail around the first turn, found a nice clean pocket for the run into the far turn, bid inside leaving the furlong marker, flattened out to the wire. RIDICULOUS raced off the pace and three wide, roused leaving the quarter pole, weakened through the stretch. BATTLE OF BASTOGNE trailed the first turn, roused inside down the backside, never threatened. PER RULING #13 FROM THE WEST VIRGINIA RACING COMMISSION, ALVY WAS DISQUALIFIED FROM FIRST TO UNPLACED DUE TO A POSITIVE TEST.
